Pokemon TCG Scanner App Privacy Policy

This Privacy Policy covers Pokemon TCG Scanner's treatment of personally identifiable information ("Personal Information") and other data that we gather when you access the Pokemon TCG Scanner App.

What personal and other information do we collect and why do we collect it?

Personal Information You Provide to Us: When you correspond with us, we receive certain information, such as your device make and model, operating system version and the app version you're using. We use this information to reply to you and improve the functionality of the Pokemon TCG Scanner App.

Analytics Information: We may directly collect analytics data, or use third-party analytics tools and services, to help us measure traffic and usage trends for the Pokemon TCG Scanner App. These tools collect information sent by your browser or mobile device, including the pages you visit and other information that assists us in improving the Pokemon TCG Scanner App. We collect and use this analytics information in aggregate form such that it cannot reasonably be manipulated to identify any particular individual user.

How Is Personal Information Used?

Service-Type Information: We may use analytics, cookies and log files to provide and monitor the effectiveness of the Pokemon TCG Scanner App, monitor aggregate metrics such as total number of visitors, traffic and demographic patterns and diagnose or fix technology problems.

Is Personal Information Shared?

We will not give, rent or sell your information to third parties outside of Pokemon TCG Scanner without your consent, except as noted below:

Instances Where We Are Required to Share Your Information: We will disclose your information where required to do so by law or subpoena or if we reasonably believe that such action is necessary to (a) comply with the law and the reasonable requests of law enforcement; (b) to protect the security, quality or integrity of the Pokemon TCG Scanner App; and/or (c) to exercise or protect the rights, property or personal safety of the Pokemon TCG Scanner App, our users or others.

We may also share certain personal information we collect about you with third parties who perform services for us or with whom we contract for the purposes described in this Privacy Policy. For example, we may use third parties to host our website, operate certain of its features, send emails, print or send mailings, conduct customer research, authorize and process your payments, manage and analyze data and our advertising effectiveness and fulfill gift card orders. These third-party service providers are given the information that they need to perform their designated functions, and we do not authorize them to use or disclose your personal information for their own or any others' marketing purposes.

On rare occasions, we may also be required to disclose your information as is required by law pursuant to lawful requests, such as subpoenas, court or agency orders or as we may reasonably determine to be necessary to protect our rights or the rights of others, to avert harm to persons or property or to enforce this Privacy Policy.

How Do We Store and Protect Your Personal Information?

Storage and Processing: Your information collected through the Pokemon TCG Scanner App may be stored and processed in the United States or any other country in which Pokemon TCG Scanner service providers maintain facilities. Pokemon TCG Scanner may transfer information that we collect about you, including personal information, to affiliated entities or to other third parties across borders and from your country or jurisdiction to other countries or jurisdictions around the world. If you are located in the European Union or other regions with laws governing data collection and use that may differ from U.S. law, please note that we may transfer information, including personal information, to a country and jurisdiction that does not have the same data protection laws as your jurisdiction, and you consent to the transfer of information to the U.S. or any other country in which Pokemon TCG Scanner or its service providers maintain facilities and the use and disclosure of information about you as described in this Privacy Policy.

Keeping Your Information Safe: Pokemon TCG Scanner cares about the security of your information, and uses commercially reasonable safeguards to preserve the integrity and security of all information collected. You are responsible for controlling access to your email communications from the Pokemon TCG Scanner App at all times. However, the Pokemon TCG Scanner App cannot ensure or warrant the security of any information you transmit to the app or guarantee that information on the app may not be accessed, disclosed, altered or destroyed. Pokemon TCG Scanner is not responsible for the functionality or security measures of any third party.

Compromise of Information: In the event that any information under our control is compromised as a result of a breach of security, Pokemon TCG Scanner will take reasonable steps to investigate the situation and where appropriate, notify those individuals whose information may have been compromised and take other steps, in accordance with any applicable laws and regulations.

Your Choices About Your Information

It is your choice to use the Pokemon TCG Scanner App. If you do not wish for Pokemon TCG Scanner to collect personal information from you, do not use the app.

To opt out of collection of your information, please refer to your mobile device or browser's technical information for instructions on how to delete and disable cookies and other tracking/recording tools. Depending on your type of device, it may not be possible to delete or disable tracking mechanisms on your mobile device.

Children's Privacy

The Pokemon TCG Scanner App does not knowingly collect or solicit any information from anyone under the age of 13. The Pokemon TCG Scanner App and its content are not directed at children under the age of 13. In the event that we learn that we have collected personal information from a child under age 13 without verification of parental consent, we will delete that information as quickly as possible.

We are not responsible for the practices employed by websites or services linked to or from the Pokemon TCG Scanner App, including the information or content contained therein. Please remember that when you use a link to go from the Pokemon TCG Scanner App to another website, our Privacy Policy does not apply to third-party websites or services.
